Participants may, in addition, submit a short conference paper (2-6 pages) to be published in a volume of Lecture Notes on Computer Science, by Springer. A selection from all presentations will also be considered for publication as full papers in a special issue of Computational Management Science.

Keynote speakers: Victor DeMiguel (London Business School), William Pulleyblank (United States Military Academy), Daniel Ralph (University of Cambridge), Rüdiger Schultz (Universität Duisburg-Essen).

A CMS Best Student Paper Prize will be awarded at the conference. Further details will be provided later.
